Application areas

As a plaster base preparation (adhesion primer) for the application of mineral plasters, such as BKM SP, on load-bearing, mineral substrates.

Product application

Surface preparation

BKM VMmust be applied to a load-bearing, largely even substrate. The surface must be self-contained, free of dust and free of substances that reduce adhesion (e.g. oils or paints). The substrate may be damp, but not wet.

Damaged masonry joints should be scraped out to a depth of approx. 2 cm.

Processing

BKM VM is mixed without lumps by adding approx. 5.5-6 liters of water. A suitable agitator (approx. 500-700/min) should be used for this purpose.

The material must be applied in a net shape according to the recognized rules of plastering technology. If BKM VM is applied in a system with mineral sealing slurries, it must be applied over the entire surface.

BKM VM should be applied in a thickness of max. 5 mm on a slightly pre-wetted substrate.

BKM VM can be processed with all common continuous mixing pumps.

Ø approx. 3.0 kg/m2/mm as adhesion primer (full-surface) Ø approx. 1.5 kg/m2/mm (reticulated-semi-covering)
